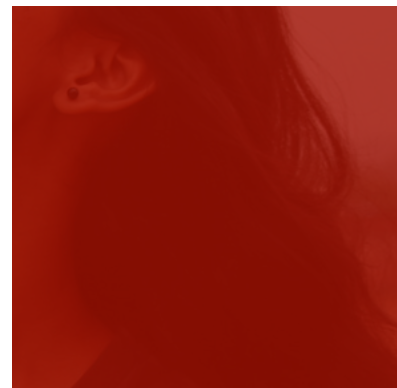

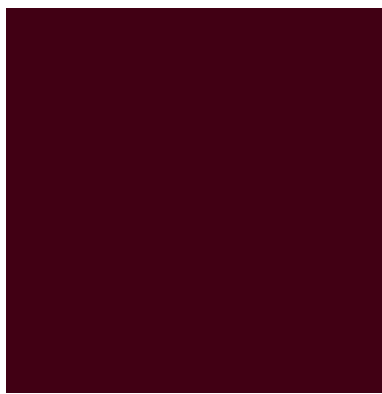

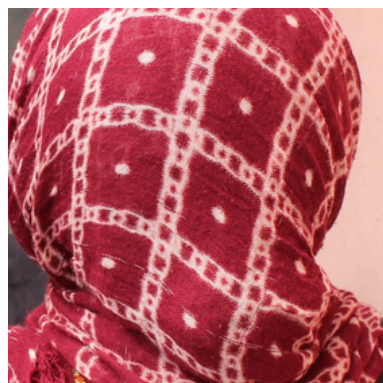
About US

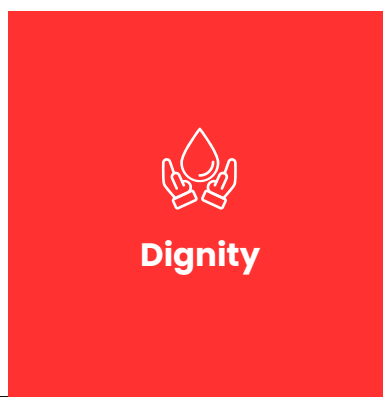

- Agency: Supporting informed decision-making with access to necessary resources for empowered lives.

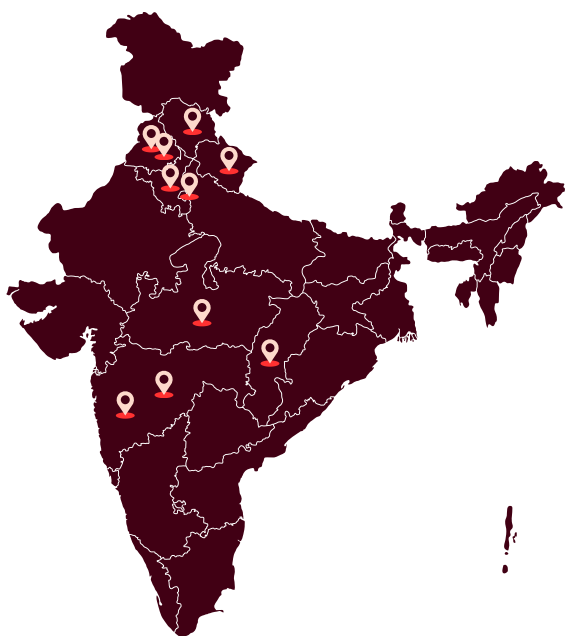




Our Network

In just two years, Azaad Titliyan has made remarkable strides, establishing a robust presence primarily in northern India while extending our reach to diverse communities across the nation. Our network now includes 1,000 female sex workers and 10 FSW CBOs, covering both northern and southern regions.

Founded by Kusum and guided by the Hum Safar Trust, we proudly operate in key locations including Dehradun, Hamirpur, Chhattisgarh, Firozpur, Amritsar, Ujjain, Delhi, Mumbai, Nagpur, and Chandigarh. Each location strengthens our commitment to addressing the unique challenges faced by female sex workers and supports our mission to create lasting, positive change.

Our Focus Area

Comprehensive Healthcare

Azaad Titliyan prioritizes providing comprehensive healthcare services to female sex workers, focusing on the prevention and treatment of sexually transmitted infections (STIs) and promoting overall health. Our interventions include:

- HIV Prevention and Awareness: Educating about HIV and promoting safe sex practices.
- Access to HIV Treatment: Providing necessary treatments and medicines.
- Health Camps: Offering screenings for cervical cancer, tuberculosis (TB), and hepatitis.

Women & Child Development

We are dedicated to addressing the diverse needs of female sex workers and their children. Our initiatives include:

- Safe and Supportive Housing: Providing secure housing options for older sex workers.
- Early Childhood Education: Facilitating access to quality education and care through creches.
- Child Education Support: Assisting in the education of the children of sex workers.
- Menstrual Hygiene Education: Promoting awareness and education about menstrual hygiene.
- Skills Development Programs: Offering training for additional income sources.

Access to Social Entitlements

Many female sex workers face barriers to accessing essential social services due to stigma, lack of documentation, and limited access to government offices. To overcome these challenges, Azaad Titliyan:

- Organizes Aadhaar Card Camps: Assists in obtaining Aadhaar cards.
- Facilitates Bank Account Openings: Helps in setting up bank accounts.

Advocacy & Legal Services

To combat stigma, discrimination, and other challenges, Azaad Titliyan provides advocacy and legal support, including:

- Abortion Rights Advocacy: Supporting access to abortion services.
- Legal Rights Awareness: Educating about health, safety, and dignity rights.
- Support Programs: Empowering community members to make informed decisions and exercise their agency.
